### Foreword

Warm wishes from GIPARD,

Training is a necessary intervention in providing efficiency in the governance process. GIPARD is ready with its Annual Training Calendar with several activities projected for the financial year 2024 – 25. GIPARD proposes nearly 342 training programmes in the areas of Panchayat Raj, Women's Development, Public Administration, Disaster Management and Rural Development expecting to cover 13,500 participants; as given in the table below:-:

The duration of these programmes vary from one day to maximum 10 days and includes foundation trainings, refresher programmes, in-service programmes, thematic training programmes, workshops, seminars, etc. The programmes are designed to meet the requirements mandated in the 'State Training Policy, 2016'. Due emphasis has been laid on the training programmes for the elected members of Panchayat Raj Institutions. The Institution has been also conducting training and review meetings for the fellows under the Goa Chief Minister's Fellowship programme since the last two years and programmes on critical areas in Public Administration are planned for the Officers, which include training programmes on Reservation Policy, Disciplinary Proceedings, Establishment Rules, Purchase Management, Right to Information Act, 2005, ICT, etc. In addition to the training programmes, modules and material for conducting these programmes are being prepared by the Institute.

The programmes are being arranged in different locations, including the Educational Institutions who have a Memorandum of Understanding with the Institute and in GIPARD itself.

Looking forward to an active participation of all the Departments through their respective Heads, as well as, Elected Representatives of Panchayat Raj Institutions and Urban Local Bodies.

## **Training Schedule and Programmes:**

- **A.** Annual Training Schedule, month wise, with dates of the various training programmes is annexed.

These programs will be conducted depending on the response from the Departments and batch size suitable for undertaking the training programs.

**C.** GIPARD conducts entry level foundation training, orientation programs (for new entrants to Government service / direct recruits / lifting of probation etc.), as also, in-service training programs (for promotee's / career advancement etc.).

Department / Grant -in- Aid Institutions / Autonomous Bodies / PSE's who may have these requirements during the year, or any other Department specific training requirement; may approach the Institute for organizing the requisite training programs, which GIPARD will arrange to impart.
